2022 New Place of Service Code (POS) for Telehealth Services

What are POS Codes?

POS codes are the 2 digit codes that specify the setting in which services are provided. Before COVID, most private practitioners only used one POS code (11) which indicates that the client received psychotherapy services in-person in the clinician's office.

Why make changes?

Provisions in the 2021 Consolidated Appropriations Act made it necessary for the Centers for Medicare & Medicaid Services (CMS) to create a new place-of-service code (10) and revise another POS code (02). These two codes will fine-tune the reporting of telehealth services, as they will distinguish between virtual services provided while the patient is at home and when the patient is elsewhere.

What are the new codes and what do they mean?

POS 10- Telehealth services that are provided when the client is located in their home. This code is NOT used when the client is residing in a hospital or facility.

POS 02 –Telehealth Services that are provided when the client is located in an environment that it not their home. (Ex. work, parking lot of Target, friend's house)

When does this go into effect?

Implementation dates appear to vary on when 3rd party payers will begin using this new code "10". It is strongly advised that before submitting claims with code "10", you seek out written correspondence regarding each insurance company's policies and implementation dates.

At this point, the Centers for Medicare and Medicaid Services plan to start using the new code "10" on April 1, 2022. Medicare providers are advised to keep an eye out for written correspondence from CMS about when the use of this new code will go into effect.
